BrightTALK offers a series of summits, each a collection of topical webcasts that run over the course of one or two days. DMTF DASH 1.0 Conformance Program Now Available

Last month DMTF proudly announced the opening of the DASH 1.0 Conformance Program to System Management Forum [SMF](#) member companies. SMF members are now able to begin testing their products using the DASH 1.0 Conformance Test Suite and then submit their results to the Program Administrator.

DMTF Conformance Programs test DMTF-based solutions for conformance to applicable specifications. Vendors who submit valid conformance test results will be eligible to list their products in the DMTF certification registry. This provides IT customers with increased confidence that products listed in the registry are manageable as defined by DMTF standards. Event Recaps: March 2010 BrightTalk Summits

BrightTALK Cloud Security Summit

On March 11, 2010, DMTF's Abolfazl Sirjani presented during the BrightTALK Online Cloud Security Summit – [Accelerating Cloud Adoption Using Virtualization Management Standards](#). During his presentation, Abolfazl discussed how existing DMTF standards enable workload interoperability across different virtualization technologies and how unified management of such virtualization standards can be utilized to achieve interoperability between private clouds within enterprises and hosted or public cloud providers.

BrightTALK Virtualization Simplicity Summit

DMTF's Winston Bumpus presented, [Simplifying Virtualization Management and Preparing for the Cloud](#), during the BrightTALK Online Virtualization Simplicity Summit last month. Winston explained how organizations look to maximize investments in the heterogeneous data center. He also discussed how capitalizing on multi-vendor industry standards is at the heart of efficiencies that can be achieved in the new cloud computing model. A standards-based approach to IT management can lead to increased flexibility and reduced costs. Lastly, he addressed the increased simplicity that can be achieved in a multi-vendor environment and explained how DMTF's Virtualization Management Initiative ([VMAN](#)) and standards, including the Open Virtualization Format ([OVF](#)) and the Virtualization Management Profiles, address these issues and ease the transition to the emerging cloud computing paradigm.

Vendors whose products pass the conformance tests will be eligible to list their products in the DMTF certification registry.

We are excited to have Thomas as the new VP of Interoperability and look forward to an exciting year.

- [DSP0004 2.6.0](#) – CIM Architecture Specification: The DMTF Common Information Model (CIM) Infrastructure is an approach to the management of systems and networks that applies the basic structuring and conceptualization techniques of the object oriented paradigm. The approach uses a uniform modeling formalism that together with the basic repertoire of object-oriented constructs supports the cooperative development of an object-oriented schema across multiple organizations.
- [DSP0226 1.1.0](#) – Web Services for Management Specification: This specification describes a Web services protocol based on SOAP for use in management-specific domains. These domains include the management of entities such as PCs, servers, devices, Web services and other applications, and other manageable entities. Services can expose only a WS-Management interface or compose the WS-Management service interface with some of the many other Web service specifications.
- [DSP0227 1.1.0](#) – WS-Management CIM Binding Specification: This specification describes how to use the Web Services for Management (WS-Management) protocol to communicate with resources modeled with CIM and exposed through the XML schema mapping described by WS-CIM.
- [DSP0230 1.0.2](#) – WS-CIM Mapping Specification: The goal of this specification is to produce a normative description of a protocol-

independent mapping of CIM models to XML Schema, WSDL fragments, and metadata fragments. The features of CIM that are within the scope of this specification correspond to a subset of the features of CIM that are defined in the CIM Infrastructure Specification, DSP0004.
